

## Compliance with China RoHS Requirements

Dear BenQ(IMS) Supplier,

On February 28, 2006, the People's Republic of China released a regulation called "Management Methods for Controlling Pollution by Electronic Information Products" or commonly referred to as China RoHS. As a supplier to BenQ(IMS), you need to be aware of the new requirements to meet the China RoHS regulation, which is effective March 1, 2007. The guidance in this letter and the documentation is offered to help you understand the China RoHS requirements, but at all times compliance shall be the responsibility of the supplier. **BenQ(IMS) expects that you will comply with all applicable laws, rules, ordinances or regulations, including, but not limited to, any applicable product environmental energy, hazardous substance and recycling regulations.** BenQ(IMS) reserves the right to require you to provide appropriate documentation verifying conformance with applicable laws, regulations, rules, and ordinances. Please review the requirements listed below and ensure that you should comply with these requirements in advance of the China RoHS effective date – March 1<sup>st</sup>, 2007 – there is no grandfathering of this requirement.

There are 3 aspects to the China RoHS labeling requirement: product labeling of **Environment-Friendly Use Period (Part 1)**, **Chemical Table (Part 2)**, and **packaging marking (Part 3)**. Please refer to "SJ/T 11364-2006 Marking for control of pollution caused by electronic information products" of China RoHS.

According to **the general rules of SJ/T 11364-2006 Marking for control of pollution caused by electronic information products,"...supplier...must provide the complete information to the purchase side which marking/labeling needs..."**. Therefore BenQ (IMS) requested the supplier replies below information to BenQ (IMS) Sourcer within two weeks:
